Model B111C/G-6TP24 Accessible Embedded mount Contoured Bench, 6 foot long, with hot dip galvanized frames and 2" x 4" treated Southern Yellow Pine seat planks

- Meets suggested ABA and ADA guidelines for accessible seating
- Grab bar across full length at top of the back aids transfer to and from bench
- Extra heavy design to be stronger and more stable with a simple, clean design.
- Sturdy, formed and welded steel frame construction
- Frames are Hot-Dip Galvanized after fabrication for superior corrosion resistance
- Precision drilled, Treated #1 Southern Yellow Pine Planks
- Quality construction throughout

SPECIFICATIONS:

- Model B111C end frames are one-piece, welded construction with a back and seat bracket of 2-3/8" x 1-1/2" x 1/8" nominal sized, die-formed channel, and a 2.375" (2-3/8") O.D. post and foot to meet 2" nominal steel pipe size specifications. Frame leg is designed to be embedded 20-1/8" into a concrete footing.
- A grab bar die-formed from 1.66" OD x 10 ga. wall round steel tube with downward bends on the ends attached to the end frames at the top of the back provides support when transferring to and from bench seat.
- Model B111C/G-6 is 6 ft. long (nom.) with three frames.
- **Standard:** Frames are hot-dip galvanized after fabrication to ASTM-A123 to maintain an average zinc coating of 2.0 oz. per sq. ft. of surface area (indicated by "/G" in model no., e.g. B111C/**G**-6TP24).
- Standard: Lumber shall be treated #1 grade Southern Yellow Pine (indicated by "TP" in model no., e.g. B111C/G-6TP24) 2" x 4" nominal sized planks, pressure treated and kiln dried after treatment (KDAT) to preserve wood against decay. All lumber shall be precision drilled to facilitate assembly and shall have all exposed edges removed to a 3/8" radius.
- All fasteners are provided for assembly.
- **Optional:** Color choices of powder coated steel frame components. For optional colors choices see Specification Bulletin #SPC-CO-001.
